May kindly see the online property statements received from Sri Sumit Kumar-II, Additional Civil Judge (Sr. Div.), Pratapgarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2020-22 (2020-21 and 2021-22) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2020-22(2020-21 and 2021-22) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2020-22 (2020-21 and 2021-22), total Gross salary is Rs.23,06,624/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, Personal loan, Insurance policies and the balance of his savings bank account(s) has also been enhanced for Rs.4,46,070/- this financial year from previous year's balance, total of which is Rs.14,08,933/-. Thus, a sum of Rs.8,97,691/- was therefore available with him to meet out the household expenditure of his family consisting four members in both of the financial years.

It is pertinent to mention here that his mother's annual income is between Rs.1-2 lacs from agriculture.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining which had already been seen online by Hon'ble Mr. Justice J. J. Munir, the then Administrative Judge, Pratapgarh. And a detailed online note has been laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Pratapgarh Judgeship for His Lordship's kind perusal and orders on eService ID P00005562023

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2020-21 and 2021-22 in its next financial year i.e., 2022-23 upto March,2023. He has submitted movable and immovable property statements for the aforesaid financial years firstly vide online dated 10.12.2021 but the statements was neither properly filled nor correct block. Accordingly objection has been raised by this Court and after that officer has submitted the properly filled correct statement on 26.08.2023. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2020-22 (2020-21 and 2021-22) of Sri Sumit Kumar-II, Additional Civil Judge (Sr. Div.), Pratapgarh be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Pratapgarh Judgeship for His Lordship's kind perusal and orders?
