May kindly see the property statement online received from Smt. Seema Singh-I, Additional District & Sessions Judge, Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2013-15 (2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2013-15 (2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below-

(1) In the financial years 2013-15 (2013-14 & 2014-15), Total Gross income from salary is Rs.18,27,733/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, LIC policy, PPF and the balance of her savings bank account(s) is enhanced for Rs.2,866/- this financial year from previous year's balance, total of which is Rs.6,28,666/-. Thus, a sum of Rs.11,99,067/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband Mr. Sandeep Chaudhary is Chief Judicial Magistrate.

In this connection, it is submitted that officer has already submitted her property statement upto financial years 2012-13 which had already been Seen by Hon'ble Mr. Justice S. S. Chauhan, Administrative Judge, Kanpur Nagar in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. She has submitted movable and immovable property statements for the financial year 2013-15 vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, she has stated that on account of work pressure and owing to oversight she has failed to submit her Property statement in time for which she tenders unconditional apology and assure the Hon'ble Court that she shall remain punctual in filing Property statement in future .

May, therefore, if approved, property statements for the financial year 2013-15 (2013-14 & 2014-15) of Smt. Seema Singh-I, Additional District & Sessions Judge, Ghaziabad be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad Judgeship for His Lordship's kind perusal and orders?
