In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2015-17(2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2015-17(2015-16 & 2016-17), Gross income is Rs.21,73,929/- (income from salary including arrears & allowances Rs.20,68,197/- and income from NSC encashment Rs.1,05,732/-) and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, PPF, LIC, repayment of car loan and the balance of his savings bank account(s) is enhanced by Rs.1,08,519/- this financial year from previous year's balance, total of which is Rs.8,58,455/-. Thus, a sum of Rs.13,15,474/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2014-15 offline and same has been seen by Hon'ble Mr. Justice Shashi Kant, the then Administrative Judge, Rampur Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2015-17(2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial years 2015-17(2015-16 & 2016-17) vide online dated 12.12.2021. As such, there is delay in submitting the same. In this regard officer has stated that due to excess of work he could not submit the statement in time. For which, he apologizes and ensure that he would submit the same on time in future and will not repeat such mistake in future.
