May kindly see the property statements online received from Smt. Shweta Srivastava-II, Civil Judge (Senior Division), Sant Kabir Nagar, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

In the financial years 2018-20(2018-19 & 2019-20), Total income from Salary is Rs.19,68,005/- and total deductions/ repayment/ savings/ investment against CPF/PRAN, GIS, Income Tax, Car Loan EMI, mutual fund and the balance of her savings bank account(s) is also increased for Rs.4,34,945/- this financial year from previous year's balance, total of which is Rs.12,83,044. Thus, a sum of Rs.6,84,961/- was therefore available with her to meet out the household expenditure of her family consisting of three members for both the financial years.

It is pertinent to mention here that her husband Mr. Lokpati Srivastava, Private Job, annual income for the F.Y. 2018-19 Approx Rs. 4,80,000/- and For the F.Y. 2019-20 Approx Rs. 5,10,000/-annual.

In this connection, it is submitted that the Officer has already submitted her property statements of the financial year 2016-18 online and same has been processed before the Hon'ble Mr. Justice Om Prakash Tripathi, Administrative Judge, Sant Kabir Nagar on old case Id no-5599.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. she has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has mentioned that delay occurred in submission of the statements is purely unintentional, she conveys her sincere apologies for the delay and undertakes to submit the statements on time in future.

May, therefore, if approved, property statements for the financial years 2018-20(2018-19 & 2019-20) of Smt. Shweta Srivastava-II, Civil Judge (Senior Division), Sant Kabir Nagar, be laid before Hon'ble Mr. Justice Om Prakash Tripathi, Administrative Judge, Sant Kabir Nagar Judgship for His Lordship's kind perusal and orders?
