May kindly see the property statement online received from Sri Prashant Kumar Singh-I, Additional Chief Judicial Magistrate, Muzaffarnagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-18 & 2018-19 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Total income from salary is Rs.29,84,555/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, PPF, NPS, Income Tax, LIC policy, TDR and the balance of his savings bank account(s) is enhanced for Rs.3,86,209/- this financial year from previous year's balance, total of which is Rs.29,08,968/-. Thus, a sum of Rs.75,587/- was therefore available with him to meet out the household expenditure of his family consisting two members in both the financial years.

It is pertinent to mention here that his wife is also a Judicial Officer having monthly income of Rs.95,000/- & Rs.1,10,000/- in the financial years 2017-18 & 2018-19 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial 2010-11 which has already been seen by Hon'ble Mr. Justice V.K.Shukla, the then Administrative Judge, Bareilly, placed in the misc. file of the officer. And property statement for the financial years 2011-12, 2012-13, 2013-14, 2014-15, 2015-16 and 2016-17 of the officer concerned has been laid offline before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that *"he could not submitted the aforesaid statements mistakenly and assured that in future he will send the further statements timely"*, mentioned in the attachment letter.

May, therefore, if approved, property statements of the financial years 2017-18 & 2018-19 of Sri Prashant Kumar Singh-I, Additional Chief Judicial Magistrate, Muzaffarnagar be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffarnagar Judgeship for His Lordship's kind perusal and orders?
