May kindly see the property statement online received from Sri Subhash Chandra Yadav, Additional Principal Judge, Family Court, Gorakhpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19(2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19(2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2017-19(2017-18 & 2018-19), Gross income is Rs.31,10,152/- (income from salary including arrears & allowances Rs.29,85,816/- and income from NSC encashment Rs.1,24,336/-) and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, PPF, LIC, repayment of car loan and the balance of his savings bank account(s) is enhanced by Rs.2,25,608/- this financial year from previous year's balance, total of which is Rs.14,52,118/-. Thus, a sum of Rs.16,58,034/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2015-17 online and same has been processed before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Gorakhpur Judgeship on old case Id no-5616.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19(2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-19(2017-18 & 2018-19) vide online dated 12.12.2021. As such, there is delay in submitting the same. In this regard officer has not given any reason for delay.
