May kindly see the property statement online received from Sri Nishchal Shukla, Deputy Secretary, U.P. State Legal Services Authority, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total Gross income from salary are Rs.21,33,043/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, PPF a/c and Car loan are Rs.7,28,678/-. Thus, a sum of Rs.14,04,365/- was therefore available with him to meet out the household expenditure of himself in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.4,359/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining into Judicial Service which has already been seen by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Barabanki in the misc file of the officer and property statement of the financial year 2016-18 has been processed on e-service ID no.1716.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which officer has stated that *"he has furnished his property statement at the time of his joining of judicial services in regard of which certain queries were raised by the Hon'ble Court. He has addressed those queries. Thereafter, for the purpose of providing the property statement, required some relevant bank statements which due to Covid-19 pandemic took some time. Further due to the first and second wave of Covid-19, he along with his old parents and his elder Uncle (who has no issue) got affected with the Covid-19 virus and was fully became the responsibility of him. Due to the above mentioned circumstances there was delay in furnishing the property details for which he regrets and seeks apology. Further, he assures your goodself that he will not commit such mistake in future"* mentioned in remark column of movable proforma.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Nishchal Shukla, Deputy Secretary, U.P. State Legal Services Authority, Lucknow be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
