May kindly see the property statement online received from Dr. Krishn Pratap Singh, Chief Judicial Magistrate, Mau regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), his gross income from salary is Rs.23,51,359/and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, and Car loan-repayment are Rs.12,00,379/-. The balance of Rs.24,668/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.11,75,648/- was therefore available with him to meet out the household expenditure of his family consisting three members in the financial years 2018-20 (2018-19 & 2019-20).

It is pertinent to mention here that officer's wife (Assistant Prosecution Officer in Prosecution Department, U.P. Govt.) having annual income was Rs.7,00,000/- (approximately) for the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2016-18 (2016-17 & 2017-18) online against case id-P00027322021 (Old Case Id :4872), and same has been processed before Hon'ble Mr. Justice Chandra Kumar Rai, Administrative Judge, Mau Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 12.12.2021. As such, there is day delay in submitting the same. In this regard officer verbatim: "I am submitting property statement (Statement of Property during Financial Year 2018-2020) before Hon'ble Court. Sir, I am seeking unconditional apology for not submitting property statement by mistake at the interval of two Financial Year. I shall be vigilant in future in this regard."

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Dr. Krishn Pratap Singh, Chief Judicial Magistrate, Mau be laid before Hon'ble Mr. Justice Chandra Kumar Rai, Administrative Judge, Mau Judgeship for His Lordship's kind perusal and orders?
