May kindly see the property statement online received from Smt. Bhavya Tiwari, Additional Chief Judicial Magistrate, Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below-

(1) In the financial years 2017-18 & 2018-19, Total Gross income from salary & arrears is Rs.21,37,179/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, NPS, Car loan, LIC policies, FDR, PPF a/c and the balance of her savings bank account(s) is enhanced for Rs.1,86,215/- this financial year from previous year's balance, total of which is Rs.8,63,647/-. Thus, a sum of Rs.12,73,532/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years.

It is pertinent to mention here that her husband is working as Review Officer in UP Civil Secretariat, Lucknow, presently posted in Excise Department of UP having monthly income of Rs.51,000/-.

In this connection, it is submitted that officer has already submitted her property statement at the time of joining into Judicial Service which had already been laid before Hon'ble Mr. Justice Manoj Kumar Gupta, the then Administrative Judge, Lucknow, in the misc. file of the officer. And property statement of the financial year 2015-17 has been processed on Statement ID 5618.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements for the financial year 2017-19 vide online dated 11.12.2021. As such, there is delay in submitting the same from the part of the officer for which she has stated that "she could not submit it on time due to complications in her pregnancy, she had to undergo critical surgery, for that she highly regret. She sincerely apologize for that." mentioned in remark column.

May, therefore, if approved, property statements for the financial year 2017-18 & 2018-19 of Smt. Bhavya Tiwari, Additional Chief Judicial Magistrate, Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
