In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the Officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2018-20, her gross income from salary is Rs.21,41,411/-and total deductions /Savings/investments against, GIS, Income Tax, PPF, LIC and repayment of car loan are Rs.6,87,324/-. Thus a sum of Rs.14,54,087/- was therefore available with her to meet out the household expenditure of her family consisting of two members in the financial year 2018-20. And the balance of her savings bank account is also reduced by Rs.40,687/- this financial year from previous year's balance.

It is pertinent to mention here that Sri Jagdish Ram (Father), Retired Assistant Controller in Weights & Measurement Department, U.P., Annual Pension Rs.434421.00/- as on 31.03.2020.

In this connection it is further submitted that the officer has submitted her property statement online with e-service case id 5656, for the financial year 2016-18 (2016-17 & 2017-18) which is also processed online and kindly be laid before Hon'ble Mr. Justice Salil Kumar Rai, the Administrative Judge, Gonda for kind perusal and orders.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statement for financial year 2018-20(2018-19 & 2019-20) in its next financial year i.e 2020-21 upto 31st March 2021. She has submitted the aforesaid statement through her online application with e-service case-id 5671, dated 14.12.2021. As such, there is delay in submitting the aforesaid statement on the part of the officer. The reason for delay as stated by the officer is that she could not submit the property statement at the time joining of service due to illness of her father and unavailability of documents. Delay Caused in submitting the property statement may kindly be condoned and she sincerely apologized for the delay in this regard.
