May kindly see the property statements online received from Sri Kumar Gaurav, Additional District & Sessions Judge, Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2018-20 (2018-19 & 2019-20), Total income is Rs.34,97,186/- (income from salary including arrears) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Insurance policies, shares and PPF are Rs.21,35,764/-. Thus, a sum of Rs.13,61,422/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.5,75,709/- this financial year from previous year's balance.

It is pertinent to be mention here that his wife Smt. Manisha having total annual income from Grant of SRF Rs. 4,00,000/- (PA) in F.Y. 2018-19 and from Teaching Rs. 2,00,000/- (PA) in F.Y. 2019-20.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2017-18 which had already been seen with the warning (which had already been informed to the officer by the Court's letter in the Misc. file of the officer) that "the officer be warned to remain careful in future to submit property statement on time" by Hon'ble Mrs. Justice Sunita Agarwal, the then Administrative Judge, Hamirpur.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same. In this regard, officer stated that the delay is occurred due to Covid-19, as he could not get his account details on time that's why he could not submit the statement on time and requested to condone the delay.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Kumar Gaurav, Additional District & Sessions Judge, Bareilly be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgship for His Lordship's kind perusal and orders?
