May kindly see the property statement received online from Sri Swatantra Singh Rawat, Addl. Civil Judge (Sr.Div.)/ACJM, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2016-18 (2016-17 & 2017-18), Gross salary is Rs.9,79,680/- and total deductions/savings/investment against GIS, NPS, Income Tax, PPF, LIC, is Rs.2,02,681/-. Thus, a sum of Rs.7,76,999/- was therefore available with him to meet out the household expenditure of his family consisting three members in both of the financial years. And the balance of his savings bank account(s) is also reduced by Rs.37,271/- in this financial year from previous year's balance.

In this connection, it is submitted that the Officer has submitted his property statement held at the time of joining into U.P. Judicial Service and the same has been processed online against Case Id : P00035572021 before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted his movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide online dated 10.12.21. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated that 'he is seeking unconditional apology for not submitting statement on time and he shall be vigilant in future in this regard', as mentioned in his attachment letter dated 19.09.2023.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Swatantra Singh Rawat, Addl. Civil Judge (Sr.Div.)/ACJM, Lucknow be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
