May kindly see the property statement submitted online received from Smt. Vineeta Singh-I, Additional Chief Judicial Megistrate, Sonbhadra regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2013-15 (2013-14 & 2014-15) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2013-15 (2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2013-15 (2013-14 & 2014-15), Total income from salary is Rs.11,07,753/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, CPF, PPF, Insurance Policy and the balance of her savings bank account(s) is also enhanced for Rs.2,77,791/- this financial year from previous year's balance, total of which is Rs.5,69,794/-. Thus, a sum of Rs.5,37,959/- was therefore available with her to meet out the household expenditure of her in both the financial years.

It is pertinent to mention here that her husband Mr. Achal Pratap Singh is Civil Judge (Sr. Div.) his Gross Salary for the financial year 2013-14 is Rs. 470809/- and his Gross Salary for the financial year 2014-15 is Rs. 688252/-

In this connection, it is submitted that the officer has already submitted her property statements online at the time of the joining, which has already been processed before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Sonbhadra on old case id no-5704.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. She has submitted movable and immovable property statements of the financial years 2013-15 (2013-14 & 2014-15) vide online dated 13.12.2021. As such, there is delay in submitting the same from the part of the officer, for which she has not given any reason.

May, therefore, if approved, property statements of the financial years 2013-15 (2013-14 & 2014-15) of Smt. Vineeta Singh-I, Additional Chief Judicial Megistrate, Sonbhadra be laid before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Sonbhadra Judgeship for His Lordship's kind perusal and orders?
