May kindly see the property statement received online from Sri Kushal Pal, Addl. Director, Inst. of Judl. Training & Research, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income from salary including arrears is Rs.46,82,405/- and total deductions/savings/ investment against GIS, GPF, PPF, RDUBI, SIP, Insurances and Income Tax is Rs.18,39,111 . Thus a sum of Rs.28,43,294/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2018-20 (2018-19 & 2019-20) and the balance of his savings account is also decreased for Rs.2,81,961/- this financial year from previous year balance.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2016-2018 (2016-17 & 2017-18) online against Case Id : P00035602021 (Old Case Id : 5708) and the same has been processed before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of officer, for which he stated in his letter as attachment dated 10.12.2021, that the delay caused due to inevitable circumstances, however if Honourable Court finds any negligence on his part for delay, He seeks unconditional apology from the core of his heart.

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Kushal Pal, Addl. Director, Inst. of Judl. Training & Research, Lucknow, be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
