May kindly see the online property statements received from Sri Chandra Mani, Additional District & Sessions Judge, Siddharth Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2012-13 & 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2012-13 & 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2012-13 & 2013-14, Total Gross income are Rs.21,25,413/- and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, Home loan, Insurance policies and PPF a/c are Rs.10,23,878/-. Thus, a sum of Rs.11,01,535/- was therefore available with him to meet out the household expenditure of his family consisting of five members in both the financial years. And the balance of his savings bank accounts has also been reduced for Rs.1,78,691/- in this financial year from previous year's balance.

It is pertinent to mention here that his wife is Head Teacher at Kaha Block, Kalsi Dehradoon Uttarakhand having annual income of of Rs.4,74,098/- and Rs.5,27,696/- in the financial years 2012-13 & 2013-14 respectively.

In this connection, it is submitted that he has already submitted his property statement upto the financial year 2010-12, which has already been seen by Hon'ble Dr. Justice Satish Chandra, the then Administrative Judge, Pilibhit, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2012-13 & 2013-14 in its next financial year i.e., 2014-15 upto March 2015. He has submitted movable and immovable property statements for the financial years 2012-13 & 2013-14 firstly vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "More Work Load. He is very sorry for delay submission of Property statement & assure to Hon'ble Court that in future, he will be very careful on timely submission of property statement," mentioned in remark column of movable proforma.

May, therefore, if approved, property statements for the financial year 2012-13 & 2013-14 of Sri Chandra Mani, Additional District & Sessions Judge, Siddharth Nagar be laid before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Siddharth Nagar Judgeship for His Lordship's kind perusal and orders?
