May kindly see the property statement submitted online received from Smt. Vineeta Singh-I, Additional Chief Judicial Megistrate, Sonbhadra regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2017-19 (2017-18 & 2018-19), Total income from salary and other sources is Rs.25,18,998/- (income from salary is Rs. 23,98,998/- and income from LIC cashback is Rs. 1,20,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, CPF, PPF, repayment of home loan, sukanya samriddhi yojna and Insurances are Rs.15,48,501/-. Thus, a sum of Rs.9,70,497/- was therefore available with him to meet out the household expenditure of her in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.2,82,661/- this financial year from previous year's balance.

It is pertinent to mention here that her husband Mr. Achal Pratap Singh is Civil Judge (Sr. Div.), Lucknow and his Earning for the finanacial year 2017-18 Gross Salary Rs. 968714/- & Earning for the financial year 2018-19 Gross Salary Rs. 1654946/-

In this connection, it is submitted that the officer has already submitted her property statements upto the financial year 2015-17 which has already been processed before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Sonbhadra on old case id no-5737.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial years 2017-19 (2017-18 & 2018-19) vide online dated 13.12.2021. As such, there is delay in submitting the same from the part of the officer, for which she has not given any reason.

May, therefore, if approved, property statements of the financial years 2017-19 (2017-18 & 2018-19) of Smt. Vineeta Singh-I, Additional Chief Judicial Megistrate, Sonbhadra be laid before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Sonbhadra Judgeship for His Lordship's kind perusal and orders?
