

## **Joint Registrar(Judicial)(Budget)**

May kindly see the property statements online received from Sri Vinay Singh, Judicial Member, Commercial Tax Tribunal, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-16 & 2016-17 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2015-16 & 2016-17 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2015-16 & 2016-17, Total income from salary is Rs.20,82,149/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, PPF, insurance policies, NPS, Home loan and the balance of his savings bank account(s) is enhanced for Rs.3,53,279/- this financial year from previous year's balance, total of which is Rs.10,30,704/-. Thus, a sum of Rs.10,51,445/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

In this connection it is submitted that officer has already submitted his property statement at the time of entering into Judicial Service which had already been seen by Hon'ble Mr. Justice Sunil Ambwani, the then Administrative Judge, Sultanpur, in the misc. file of the officer and of the financial years 2009-10 to 2014-15, detailed office note has been laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2015-16 & 2016-17 in its next financial year i.e., 2017-18 upto March, 2018. He has submitted movable and immovable property statements for the financial years 2015-16 & 2016-17 vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "he did not submit his statement at that time due to busy in treatment of his wife who faced unfortunate miscarriage and excess official work. For this please accept his sincere and unconditional apology and in the future, he will submit his statement within the prescribed time period", mentioned in remark column of movable proforma.

May, therefore, if approved, property statements for the financial year 2015-16 & 2016-17 of Sri Vinay Singh, Judicial Member, Commercial Tax Tribunal, Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
