In this connection, it is submitted that the officer has already submitted her property statements upto the financial year 2017-19 which has already been processed before Hon'ble Dr. Justice Gautam Chowdhary, Administrative Judge, Sonbhadra on old case id no-5759.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial years 2019-21 (2019-20 & 2020-21) vide online dated 13.12.2021. As such, there is no delay in submitting the same from the part of the officer.
