May kindly see the property statement received online from Smt. Kumud Upadhyay, Civil Judge (Senior Division), Hathras, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial year 2018-20 (2018-19 & 2019-20), the Gross income from salary is Rs. 20,27,162/and total deductions/ repayment/ savings/ investment against GIS, PPF, NPS, Mutual Fund, Income Tax, down payment and car loan are Rs.8,81,937/- and the balance of her savings bank account is also enhanced by Rs. 3,23,114/- in this financial year from previous year's balance, total of which is Rs.12,05,051/-. Thus, a sum of Rs. 8,22,111/- was therefore available with her to meet out the household expenditure of her family consisting three members of the financial year 2018-20 (2018-19 & 2019-20).

It is also pertinent to mention here that the Officer's father is a farmer whose annual income from agriculture is approx. Rs. 60,000/-.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2016-18 (2016-17 & 2017-18), online against Case Id: P00034952021 (Old Case Id: 5642) and the same has been processed before Hon'ble Mr. Justice Manish Kumar, Administrative Judge, Hathras for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 11.12.2021. As such, there is delay in submitting the same from the part of the officer. In this regard, the officer has given reason of delay (in her verbatim), as under:

"I am seeking unconditional apology for not submitting property statement on the time. I shall be vigilant in future in this regard. Your Honour be pleased enough to condone the delay in submitting property statement."
