May kindly see the property statement online received from Sri Sanjay Kumar Yadav-III, Presiding officer Motor Accident Claims Tribunal, Maharajganj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2013-15 (financial yearsx 2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2013-15 (financial years 2013-14 & 2014-15) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2013-15 (financial year 2013-14 & 2014-15), Gross income from salary is Rs.20,07,676/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, PPF, repaymnt of loan and the balance of his savings bank account(s) is enhanced for Rs.55,923/- this financial year from previous year's balance, total of which is Rs.10,08,780/-. Thus, a sum of Rs.9,98,896/- was therefore available with him to meet out the household expenditure of his family consisting seven members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of entering into judicial service which had been processed on Case ID no.5767 before Hon'ble Mr. Justice Ajit Singh Administrative Judge, Maharajganj.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial year 2013-15 (financial years 2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto March 2016. He has submitted movable and immovable property statements of the financial year 2013-15 (financial years 2013-14 & 2014-15) firstly vide online dated 11.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that

property statement was sent in the hard copy previously which was returned with the direction to be sent online. Thereafter, when online submission was made, the same was returned with objection of entry made in the wrong columns. When the objection was addressed, then the previous property statement was withdrawn.

It is further submitted, that due to the abovementioned reasons, all the property statements could not be sent on time. In future, I shall ensure that the statements be submitted on time. Kindly accept my sincere excuse for reasons of delay.
