May kindly see the online property statements received from Sri Pran Vijay Singh, Additional District & Sessions Judge, Barabanki regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.55,74,803/- (total Gross income from salary & arrears are Rs.51,64,521/- and Bank interests of Rs.4,10,282/-) and total deductions against CPF, GIS, Income Tax, PPF, Insurance policies, FDR and the balance of his savings bank account(s) has also been enhanced for Rs.1,34,934/- this financial year from previous year's balance, total of which is Rs.46,59,767/-. Thus, a sum of Rs.9,15,036/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Ajit Kumar, the then Administrative Judge, Ballia.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-19 & 2019-20 firstly vide online dated 11.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "he could not submit the aforesaid statements due to lockdown in the last week of march,2021 because of Covid-19 pandemic, thereafter his family has affected by the Covid. Even, he has also suffered from Covid on April,2021 and taken leave from 11.04.2021 to 07.05.2021 & Earned Leave from 08.05.2021 to 08.06.2021. Due to these circumstances, he could not submit the aforesaid statements inadvertently. He has apologized and requested to consider the statements. In future, he wil submit the further statements in time.", mentioned in attachment
