May kindly see the property statements online received from Sri Alok Kumar Srivastava, Additional District & Sessions Judge, Allahabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2017-19 (2017-18 & 2018-19), Total income from salary is Rs.30,11,143/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, LIC policies, PPF, Sukanya Samriddhi Account, SIPs and the balance of his savings bank account(s) is enhanced for Rs.3,06,813/- this financial year from previous year's balance, total of which is Rs.14,17,537/-. Thus, a sum of Rs.15,93,606/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that officer has submitted his property statement upto the financial year 2016-17, which has already been seen by Hon'ble Mr. Justice Yashwant Varma, the then Administrative Judge, Allahabad.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "he seeks unconditional apology from Hon'ble High Court for not submitting his property statements on time due to COVID-19, for this he has highly obliged", mentioned in attachment.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Alok Kumar Srivastava, Additional District & Sessions Judge, Allahabad be laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders?
