In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

In the financial years 2018-20 (2018-19 & 2019-20), total income from salary & arrears is Rs.52,67,947/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, PPF, SIP, insurances, Sukanya Samridhi Yojna, repayment of car loan & installment, gold and the balance of his savings bank account(s) is enhanced for Rs.6,75,955/- this financial year from previous year's balance, total of which is Rs.40,84,263/-. Thus, a sum of Rs.11,83,684/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that wife of the officer Smt Archana Singh is Associate Advocate, Varishtha Legal Solution New Delhi and her annual income for the F.Y. 2018-19 Rs.5,58,022/- &for the F.Y. 2019-20 Rs. 4,57,220/-.

In this connection, it is submitted that the officer has already submitted his property statement of the financial year 2017-18, which had already been approved by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Sitapur on old case Id no-265.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer, for which he has not given any reason.

May, therefore, if approved, property statements of the financial years 2018-20 (2018-19 & 2019-20) of Sri Gagan Kumar Bharti, Additional District & Sessions Judge, Kasganj be laid before Hon'ble Mr. Justice Brij Raj Singh, Administrative Judge, Kasganj for His Lordship's kind perusal and orders?
