May kindly see the property statement submitted online received from Smt. Reema Malhotra, Additional District and Sessions Judge, Muzaffar Nagar regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year, 2019-21 (2019-20 & 2020-21), her Total income from salary and Bank Interest is Rs. 39,07,277/- (Total Salary Rs. 36,62,325/-, bank Interest Rs. 2,44,952/-) and total deductions/savings/investments against GIS, NPS, Income Tax, PPF, Insurances (LICs), and Plot Loan is Rs. 16,01,382/-. Thus a sum of Rs. 23,05,895/- was therefore available with her to meet out the household expenditure of her family consisting of four members in both the financial years. The balance of her savings bank account(s) is also reduced for Rs. 27,19,438/- this financial year from previous year's balance.

It is pertinent to mention here that her husband Sri Ritish Sachdeva is Additional District and Sessions Judge (FTC) Etah and his total income is 35.40 lakhs approximately in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2017-19 (2017-18 and 2018-19) which has already been seen online by Hon'ble Mr. Justice Pankaj Bhatia, the then Administrative Judge, Etah on e-service old case Id no. 534 on 29.06.2021.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto 31st March 2022. She has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) online on 10.12.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Smt. Reema Malhotra, Additional District and Sessions Judge (FTC), Muzaffar Nagar be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffar Nagar for His Lordship's kind perusal and orders?
