May kindly see the property statement received online from Sri Harish Chandra, A.D.J. (FTC), Ballia, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2015-2017 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2015-2017 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2015-2017 (2015-16 & 2016-17), the Gross income from salary including arrears is Rs.18,12,505/- and total deductions/savings/investment against GIS, PPF, NPS, PLI, SIP, Loan Repayments, Sukanya Samriddhi Account, Insurances and Income Tax is Rs.7,90,088/- and the balance of his savings bank account(s) is also increased by Rs.2,85,668/- in this financial year from previous year's balance, total of which is Rs.10,75,756/-. Thus, a sum of Rs.7,36,749/- was therefore available with him to meet out the household expenditure of his family consisting five members of the financial year 2015-2017 (2015-16 & 2016-17).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2013-2015 (2013-14 & 2014-15) online against Case Id: P00036762021 (Old Case Id: 5824) and the same has been processed before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Ballia Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2015-2017 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has firstly submitted movable and immovable property statements of the financial year 2015-2017 (2015-16 & 2016-17) vide online dated 11.12.2021. As such, there is delay in submitting the same for which the officer stated in his letter as attachment dated 10.12.2021, that he joined the Uttar Pradesh Judicial Service on 16.07.2009. But, due to lack of proper information and due to some family problems, busyness and global pandemic, the property statements could not be submitted by him within the time prescribed by the Hon'ble High Court. He apologized for the delay in sending the property statements and ensures that in future he will send property statements in time.

May, therefore, if approved, property statements for the financial year 2015-2017 (2015-16 & 2016-17) of Sri Harish Chandra, A.D.J. (FTC), Ballia, be laid before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge, Ballia Judgeship for His Lordship's kind perusal and orders?
