May kindly see the property statement received online from Smt. Tanu Bhatnagar, Addl. District & Sessions Judge, Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2017-2019 (2017-18 & 2018-19), the Gross income from salary and arrears is Rs.24,65,575/- and total deductions/ repayment/ savings/ investment against GIS, NPS, PPF, Car Loan repayments including downpayments and Income Tax are Rs.13,90,165/- and the balance of her savings bank account is also increased by Rs.5,95,446/- in this financial year from previous year's balance, total of which is Rs.19,85,611/-. Thus, a sum of Rs.4,79,964/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial year 2017-2019 (2017-18 & 2018-19).

It is pertinent to mention here that Officer's husband Mr. Rohit Singh is a Judicial Officer having salary of Rs.11,83,843/- & Rs.17,71,272/- respectively for the both financial year.

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements for the financial year 2015-2017 (2015-16 & 2016-17) online against Case Id : P00036732021 (Old Case Id : 5821) and the same has been processed before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 13.12.2021. As such, there is delay in submitting the same from the part of the officer for which, the officer has stated that "*I have not submitted property statement with in time for which with folded handed hands, I humbly apologize. I assured that in future I will keep submitting the statement with in time.*", in the remark column and she has also attached delay explanation letter dated 13.12.2021

May, therefore, if approved, property statements for the financial year 2017-2019 (2017-18 & 2018-19) of Smt. Tanu Bhatnagar, Addl. District & Sessions Judge, Lucknow, be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
