May kindly see the property statements online received from Sri Vinay Singh, Judicial Member, Commercial Tax Tribunal, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2019-20 & 2020-21 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2019-20 & 2020-21, Total income from salary is Rs.34,61,012/- and total deductions/ repayment/ savings/ investment against GIS, Income Tax, PPF, insurance policies, NPS, Home loan and the balance of his savings bank account(s) is enhanced for Rs.3,39,733/- this financial year from previous year's balance, total of which is Rs.22,96,586/-. Thus, a sum of Rs.11,64,426/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that his wife is Asst. Professor, Mahila Degree College, having annual income of Rs. 873953/- and Rs. 926874/- in the financial years 2019-20 & 2020- 21 respectively.

In this connection it is submitted that officer has already submitted his property statement at the time of entering into Judicial Service which had already been seen by Hon'ble Mr. Justice Sunil Ambwani, the then Administrative Judge, Sultanpur, in the misc. file of the officer and of the financial years 2009-10 to 2014-15, detailed office note has been laid before Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders, in the misc. file of the officer. And statement of 2015-16 & 2016-17 and 2017-18 & 2018-19 has been processed on e-Service ID 5776 and 5808 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March, 2022. He has submitted movable and immovable property statements for the financial years 2019-20 & 2020-21 vide online dated 10.12.2021. As such, there is no delay in submitting the same.
