May kindly see the property statement online received from Sri Ashok Kumar-VII, Principal Judge, Family Court, Azamgarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-2020(2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-2020(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-2020(2018-19 & 2019-20), Total income is Rs.61,92,221/- (Gross income from salary is Rs.55,06,300/-, Agriculture HUF Income is Rs.3,00,000/- , LIC Matured for Rs.1,85,921/- and GPF withdrawal of Rs.2,00,000/-) and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, SBI Loan, FDR , total of which is Rs.30,76,220/-. Thus, a sum of Rs.31,16,001/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years and the balance of his savings bank account(s) is decreased by Rs.2,32,327/- this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2014-16 & 2016-18 offline and same has been moved before Hon'ble Mr. Justice Saurabh Shyam Shamshery, Administrative Judge, Azamgarh Judgeship in Misc. file of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-2020(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-2020(2018-19 & 2019-20) vide online dated 15.12.2021. As such, there is delay in submitting the same. In this regard officer has stated that "DELAY IN SUBMISSION HAS OCCASIONED DUE TO FREQUENT TRANSFERS IN FINANCIAL YEAR AND COVID-19".

May, therefore, if approved, property statements for the financial years 2018-2020(2018-19 & 2019-20) of Sri Ashok Kumar-VII, Principal Judge, Family Court, Azamgarh be laid before Hon'ble Mr. Justice Saurabh Shyam Shamshery, Administrative Judge, Azamgarh for His Lordship's kind perusal and orders?
