May kindly see the property statement received online from Sri Mayank Prakash, Civil Judge (Senior Div.), Kasia- Kushi Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.21,50,607/- and total deductions/savings/investment against GIS, NPS, Income Tax, PPF, LIC, Medical insurance and the balance of his bank account(s) is also enhanced by Rs.50,004/- in this financial year from previous year's balance, total of which is Rs.5,56,580/-. Thus, a sum of Rs.15,94,027/- was therefore available with him to meet out the household expenditure of his family consisting six members in both of the financial years. It is pertinent to mention here that his father is a retired government officer and his monthly pension is Rs.90,000/- (approx.), as mentioned by the officer.

In this connection, it is submitted that the Officer has submitted his property statement upto the financial year 2016-18 and the same has been approved online against Case Id : P00016822021 by Hon'ble Mr. Justice Rajiv Gupta, the then Administrative Judge, Saharanpur Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted his movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide online dated 10.12.21. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated (in his verbatim) that "It is most humbly submitted that pursuant to the aforesaid subject, I am hereby sending property statement for financial year 2018-2020 for kind perusal of the Hon'ble court. I hereby apologize that due to mistake I couldn't send the aforesaid property statement on time. I assure that in future I will send all the property statement before due date".

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Mayank Prakash, Civil Judge (Senior Div.), Kasia- Kushi Nagar be laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Kushinagar at Padrauna Judgeship for His Lordship's kind perusal and orders?
