May kindly see the property statement online received from Smt. Jyoti Singh, Additional Principal Judge, Family Court, Aligarh regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2017-19 (2017-18 & 2018-19), her gross income from salary is Rs.28,53,869/- and total deductions/Savings/investments against Savings in Bank account, GPF, GIS, Income Tax, PPF, Mutual Funds, Sukanya Samriddhi Yojna, Repayment of home loan and Insurances are Rs.17,57,680/-. The balance of Rs.1,81,977/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.10,96,189/- was therefore available with her to meet out the household expenditure of her family consisting four members in the financial years 2017-19 (2017-18 & 2018-19).

It is pertinent mention here that's Officer's Husband (Interior Designer Consultant and Agricultural income) having annual income was Rs.4,22,890/- for the financial year 2017-18 and Rs.4,65,476/- for the financial year 2018-19 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement up to the the financial years 2009-10 to 2016-17 offline, which had already been seen by Hon'ble Mr. Justice Manoj Misra, the then Administrative Judge Meerut in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide dated 11.12.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer verbatim: "my father was not well at that time, I got very much disturbed that's why I could not send my property statement with in time. Please consider it Empathetically".

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Smt. Jyoti Singh, Additional Principal Judge, Family Court, Aligarh be laid before Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
