May kindly see the property statement online received from Smt. Mirza Zeenat, A.D.J. (FTC), Budaun regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2017-19 (2017-18 & 2018-19), her gross income from salary is Rs.37,45,248/- and total deductions/Savings/investments against NPS, GIS, Income Tax, PPF, NSC, FD, Repayment of car loan and down-payment are Rs.22,95,448/-. The balance of Rs.39,167/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.14,88,967/- (Rs.14,49,800/- from salary and Rs.39,167/- from saving bank account withdrawal) was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2017-19 (2017-18 & 2018-19).

It is pertinent mention here that's Officer's Husband (Business of handicraft) having annual income of Rs.7,48,000/- for the financial years 2017-18 & 2018-19 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2009-10 to 2016-17 offline, which had already been seen by Hon'ble Mr. Justice Saurabh Lavania, Administrative Judge, Budaun Judgeships in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She had submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online dated 10.12.2021 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer verbatim: "Due to some personal work in my home I couldn't send it on time which is highly regretted."

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Smt. Mirza Zeenat, A.D.J. (FTC), Budaun be laid before Hon'ble Mr. Justice Saurabh Lavania, Administrative Judge, Budaun Judgeship for His Lordship's kind perusal and orders?
