May kindly see the property statement received online from Sri Rohit Singh, Spl. Judge (Ayurved Scam Matter), Lucknow, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2017-2019 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2017-2019 (2017-18 & 2018-19), the Gross income from salary is Rs.29,55,115/- and total deductions/savings/investment against GIS, NPS, Mutual Fund, Insurances and Income Tax is Rs.15,84,501/- and the balance of his savings bank account(s) is also increased by Rs.2,29,450/- in this financial year from previous year's balance, total of which is Rs.18,13,951/-. Thus, a sum of Rs.11,41,164/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2017-2019 (2017-18 & 2018-19).

It is pertinent to mention here that his wife Smt. Tanu Bhatnagar is a Judicial Officer having annual income Rs.11,61,509/- and Rs.13,04,066/- for the financial year 2017-18 & 2018-19 respectively.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2015-2017 (2015-16 & 2016-17) online against Case Id: P00004902021 (Old Case Id: 2527) and the same has been processed before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-2019 (2017-18 & 2018-19) vide online dated 13.12.2021. As such, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, the officer has stated that (in his verbatim) "I have not submitted property statement with in time for which with folded hands, I humbly apologize. I assured that in future I will keep submitting the statement with in time." in the remark column.

May, therefore, if approved, property statements for the financial year 2017-2019 (2017-18 & 2018-19) of Sri Rohit Singh, Spl. Judge (Ayurved Scam Matter), Lucknow, be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
