May kindly see the online property statement received from Smt. Neelima Singh, Addl. District & Sessions Judge, Prayagraj regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

**(1) In the financial years 2017-18 & 2018-19**, Total Gross income is Rs.27,88,201/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income tax, NPS and PPF are Rs.8,04,287/-. Thus, a sum of Rs.19,83,914/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.2,61,912/- this financial year from previous year's balance.

It is pertinent to mention here that her husband earns annual income of Rs.8,15,311/- and Rs.9,92,396/- from Advocacy in the financial years 2017-18 & 2018-19 respectively.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into judicial service which had already been seen by Hon'ble Mr. Justice Abhinava Upadhyay, the then Administrative Judge, Jaunpur placed in the misc. file of the officer. And of the financial years 2009-10 & 2010-11, 2011-12 & 2012-13, 2013-14 & 2014-15 and 2015-16 & 2016-17 detailed online notes has been submitted on e-service ID nos. 2874, 5749, 5796 and 5816 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 firstly vide online dated 11.12.2021. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial years 2017-18 & 2018-19 (2017-19) of Smt. Neelima Singh, Addl. District & Sessions Judge, Prayagraj be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Prayagraj Judgeship for His Lordship's kind perusal and orders?
