May kindly see the property statement online received from Sri. Santosh Rai, District & Sessions Judge, Prayagraj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18(2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18(2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18 (2016-17 & 2017-18), Gross income from salary and arrears is Rs.36,27,594/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, LIC Policy and the balance of his savings bank account(s) is enhanced by Rs.19,774/- this financial year from previous year's balance, Total of which is Rs.15,91,587/-. Thus, a sum of Rs.20,36,007/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

It is pertinent to mention here that his wife is working as dentist earned Rs.7,64,521/- in both the financial years and his father's annual income in the F.Y. 2016-17 was Rs.1,50,000.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2014-16 online against case id-P00037412021 (Old Case Id : 5889) and same has been moved before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18(2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has finally submitted movable and immovable property statements of the financial years 2016-18(2016-17 & 2017-18) vide online dated 19.05.2022. As such, there is delay in submitting the same. In this regard officer has stated that there was some family partition dispute related to property etc. which has been compromised orally and settled now. he have tried to submit the statement in time but during the preparation of the statement at some points i.e. revenue records of property, which were earlier in the name of his father, were not available with him in time. he had collected relevant papers and then submitted the statement. he apologize for delay submission of statement, unconditionally. he insure that he will furnish the property statement in future in time. It is therefore, requested that the delay in submission may kindly be condoned.

May, therefore, if approved, property statements for the financial years 2016-18(2016-17 & 2017-18) of Sri. Santosh Rai, District & Sessions Judge, Prayagraj, be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders?
