

## **Registrar(J)(Budget)**

May kindly see the online property statements received from Sri Prashant Kumar Singh-II, the then Judicial Magistrate, Faizabad presently posted as Civil Judge (Sr. Div.) Varanasi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

1. In the financial years 2018-20 (2018-19 & 2019-20), Total income from salary is Rs.15,77,475/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, PPF, FD and the balance of his savings bank account(s) is enhanced by Rs.1,08,143/- this financial year from previous year's balance, total of which is Rs.5,09,187/-. Thus, a sum of Rs.10,68,288/- was available with him to meet out the household expenditure of himself in both of the financial years.

In this connection, it is submitted that the officer has already submitted his property statements at the time of joining into Judicial Service which had been submitted online before Hon'ble Mr. Justice Manish Mathur, the then Administrative Judge, Faizabad/Ayodhya for His Lordship's kind perusal and orders on eService ID P00014692021 on which His Lordship has been pleased to pass the order which had been communicated to the officer for compliance in the respective ID. And His Lordship had also been pleased to order dated 08.12.2023 in this statement of the financial year 2018-20 that **"Put up along with the statement of properties held by the officer at the time of his joining, which stands reverted."**

Now the officer has submitted the reply in compliance of Hon'ble Court's order in the matter of property statement held at the time of joining, which has been laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Varanasi for His Lordship's kind perusal and orders on eService ID P00014692021.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) firstly vide online dated 13.12.2021. As, there is delay in submitting aforesaid property statements from the part of the officer. In this regard, officer has mentioned in the attachment dated 10.12.2021, that *"I have Joined this service as Civil Judge (J.D.) F.T.C. Etawah on 27.07.2018. I could not submit my property statement for Financial year (01.04.2018 to 31.03.2020) in due time since both of my parents were suffering from severe COVID-19. Delay is deeply regretted. I will be careful in future."*

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Prashant Kumar Singh-II, Civil Judge (Sr. Div.) Varanasi be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Varanasi for His Lordship's kind perusal and orders?
