May kindly see the property statement online received from Smt. Jyoti Singh, Additional Principal Judge, Family Court, Aligarh regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2019-21 (2019-20 & 2020-21) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2019-21 (2019-20 & 2020-21) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial years 2019-21 (2019-20 & 2020-21)**, her gross income from salary is Rs.39,90,614/- and total deductions/Savings/investments against GPF, GIS, Income Tax, PPF, Mutual Funds, Repayment of home loan & advance (Margin money of Home loan), Kotak Gold Fund and Insurances are Rs.36,82,528/-. The balance of Rs.2,32,453/- has decreased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.5,40,539/- (Rs.3,08,086/- from salary and Rs.2,32,453 from saving bank account withdrawal) was therefore available with her to meet out the household expenditure of her family consisting four members in the financial years 2019-21 (2019-20 & 2020-21).

It is pertinent mention here that's Officer's Husband (Interior Designer Consultant and Agricultural income) having annual income was Rs.4,93,320/- for the financial year 2019-20 and Rs.5,96,410/- for the financial year 2020-21 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the the financial years 2017-19 (2017-18 & 2018-19) online against case id-P00037352021 (old case id-5883) and same has been processed before Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders .

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements for the financial years 2019-21 (2019-20 & 2020-21) vide dated 11.12.2021 on eServicesJo portal. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2019-21 (2019-20 & 2020-21) of Smt. Jyoti Singh, Additional Principal Judge, Family Court, Aligarh be laid before Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
