May kindly see the property statements online received from Sri Ajay Kumar-I, Additional District & Sessions Judge, Hathras regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income from salary is Rs.46,27,900/- (income from salary is Rs.41,02,880/-, LLM arrear of Rs.2,41,824/- and Int. Rel. of Rs.2,83,196/-) and total deductions/ repayment/ savings/ investment against GIS, Income Tax, CPF, PPF a/c, Sukanya Samriddhi Yojna, FD, mutual funds and Insurance policies are Rs.20,40,466/-. Thus, a sum of Rs.25,87,434/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year. And the balance of his savings bank account(s) is also reduced for Rs.1,71,139/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is a Judicial Officer having annual income of Rs.18,33,409/- and Rs.16,35,971/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto financial years 2015-16 which had already been seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Fatehpur and Property statement of the financial years 2016-18 has been submitted offline before Hon'ble Mr. Justice Manish Kumar, the then Administrative Judge, Hathras for His Lordship's Kind perusal and order.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March, 2021. He has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 vide online dated 10.12.2021. As such, there is delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Ajay Kumar-I, Additional District & Sessions Judge, Hathras be laid before Hon'ble Mr. Justice Anish Kumar Gupta, Administrative Judge, Hathras Judgship for His Lordship's kind perusal and orders?
