May kindly see the property statement online received from Sushri Anupam Singh, Additional Civil Judge (Senior Division)/ACJM, Mathura, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20) , Gross income from salary is Rs.21,83,933/- and total deductions/ repayment/ savings/ investment against GIS,NPS,PPF, Income Tax and the balance of her savings bank account(s) is enhanced by Rs.83,353/- this financial year from previous year's balance, total of which is Rs.8,42,932/-. Thus, a sum of Rs.13,41,001/- was available with her to meet out the household expenditure of her family consisting of three members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted her property statements of the Joining online against Case Id : P00001062020 (Old Case Id : 680) and same has been approved by the Hon'ble Mr. Justice Pankaj Naqvi, the then, Administrative Judge, Pilibhit and financial year 2016-18 (2016-17 & 2017-18) against Case Id : P00001162020 (Old Case Id : 692) has been moved before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Mathura for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 10.12.2021. As such, there is delay in submitting the Property statement for which officer has not stated any reason.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sushri Anupam Singh, Additional Civil Judge (Senior Division)/ACJM, Mathura be laid before Hon'ble Mr. Justice Piyush Agrawal, Administrative Judge, Mathura for His Lordship's kind perusal and orders?
