May kindly see the online property statement received from Smt. Neelima Singh, Addl. District & Sessions Judge, Prayagraj regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2019-20 & 2020-21 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2019-20 & 2020-21 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2019-20 & 2020-21, Total Gross income is Rs.31,45,516/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income tax, NPS, PPF and the balance of her savings bank account(s) is enhanced for Rs.1,65,375/- this financial year from previous year's balance, total of which is Rs.13,06,717/-. Thus, a sum of Rs.18,38,799/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband earns annual income of Rs.9,97,000/- and Rs.9,00,000/- from Advocacy in the financial years 2019-20 & 2020-21 respectively.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into judicial service which had already been seen by Hon'ble Mr. Justice Abhinava Upadaya, the then Administrative Judge, Jaunpur placed in the misc. file of the officer. And of the financial years 2009-10 & 2010-11, 2011-12 & 2012-13, 2013-14 & 2014-15, 2015-16 & 2016-17 and 2017-18 & 2018-19 detailed online notes has been submitted on e-service ID nos. 2874, 5749, 5796, 5816 and 5897 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2019-20 & 2020-21 in its next financial year i.e., 2021-22 upto March 2022. She has submitted movable and immovable property statements of the financial years 2019-20 & 2020-21 vide online dated 11.12.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial years 2019-20 & 2020-21 (2019-21) of Smt. Neelima Singh, Addl. District & Sessions Judge, Prayagraj be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Prayagraj Judgeship for His Lordship's kind perusal and orders?
