May kindly see the property statement received online from Sri Vijay Kumar-IV, Addl. District & Sessions Judge Ghazipur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18 (2016-17 & 2017-18), Gross income (from salary including Arrears) is Rs.18,60,037/- and total deductions/ savings/ investment against NPS, GIS, Income Tax, PPF, F.D., PLI and the balance of his savings bank account(s) is enhanced by Rs.5,64,708/- in this financial year from previous year's balance, total of which is Rs.15,94,621/-. Thus, a sum of Rs.2,65,416/- was available with him to meet out the household expenditure of his family consisting of two members in both of the financial years.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial year 2015-16 offline and same has been seen by the Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Ramabai Nagar in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property Statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) vide online dated 15.12.2021. As such, there is delay in submitting the same from part of the officer. The officer has attached a letter dated 19.02.2022, along with his property statement of financial year 2018-20, mentioning therein :- "due to Covid-19 pandemic and premature transfer from Kanpur dehat to Lalitpur, he was not got time to collect all the relevant documents relating to property statement on time and he admitted that it was a mistake on his side as it was due to the compelling circumstances and he assured that it will not happen again in near future".

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Vijay Kumar-IV, Addl. District & Sessions Judge Ghazipur be laid before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ghazipur for His Lordship's kind perusal and orders?
