It is also pertinent to mention here that the officer's wife is a Judicial Officer whose annual gross income is Rs.21,03,847/- for the financial year 2019-21 (2019-20 & 2020-21).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2017-19 (2017-18 & 2018-19) online against Case Id: P00031242021 (Old Case Id: 5267) and the same has been processed before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2019-21 (2019-20 & 2020-21) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial year 2019-21 (2019-20 & 2020-21) vide online dated 11.12.2021. As such, there is no delay in submitting the same.
