May kindly see the property statement received online from Smt. Poonam Rajput, Spl. Judge (U.P. Dacoity.A.A.), Mainpuri, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2016-2018 (2016-17 & 2017-18) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2016-2018 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial year 2016-2018 (2016-17 & 2017-18), the Gross income from salary is Rs.31,41,131/- and total deductions/ repayment/ savings/ investment against GIS, GPF, PPF, Personal Loans repayments and Income Tax are Rs.12,46,446/-. Thus, a sum of Rs.18,94,685/- was therefore available with her to meet out the household expenditure of her family consisting three members of the financial year 2016-2018 (2016-17 & 2017-18) and the balance of her savings bank account is also decreased by Rs.16,928/- in this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted her property statement for the financial year 2014-15 & 2015-16 offline and the same has been seen by Hon'ble Mr. Justice Abhinava Upadhya, the then Administrative Judge, Muzaffarnagar Judgeship, in the misc. file of the officer with the direction that "*The Officer be prompt in submitting the declaration*." The order of the Hon'ble Court was communicated to the officer vide Court's letter No. 5784/IV-3065/Admin(A) dated. 06.04.2018.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2016-2018 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statements of the financial year 2016-2018 (2016-17 & 2017-18) vide online dated 18.12.2021. As such, there is delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2016-2018 (2016-17 & 2017-18) of Smt. Poonam Rajput, Spl. Judge (U.P.
