

## **Registrar(J)(Budget)**

May kindly see the online property statement received from Km. Shikha Pradhan, Additional District & Sessions Judge, Kasganj regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**(1) In the financial years 2018-19 & 2019-20**, Total income is Rs.42,98,873/- [Gross salary (for both the financial years) are Rs.36,73,636/- and other sources (ACP, ACP arrear, 7th pay commission, IR, Arrear D.A., salary arrear & Mutual Fund) are Rs.6,25,237/-] and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, PPF, PLI, Insurance policies, RD, Mutual Fund and medical policy are Rs.18,34,421/-. Thus, a sum of Rs.24,64,452/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.81,909/- this financial year from previous year's balance.

It is pertinent to mention here that her father is retd. Army Officer (pensioner) and her sister is salaried in UK Govt. Rules (N.H.S.).

In this connection, it is submitted that the officer has already submitted her property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Vimlesh Kumar Shukla, the then Administrative Judge, Moradabad, placed in the misc. file of the officer. Property statements of the financial years 2010-11 & 2011-12, 2012-13 & 2013-14, 2014-15 & 2015-16 and 2016-17 & 2017-18 have been processed on e-service IDs 1521, 5902, 5946 and 5965 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 15.12.2021. As such, there is delay in submitting the same from the part of the officer for which she has mentioned in the attachment letter that *"due to her father being old and fragile he is unable to live independently as he is bed bound and wheel chair bound. He needs full time care. Her mother who is 77 years old and is recovering from a complex fracture which needed a surgical implant in her right leg. As her parent being all alone she have to assist her elderly parents in this phase of their lives and being the only daughter to look after them as her elder sister lives abroad. She was unable to send her property statements on time due to fire incident in Court room there was excess workload at previous station for running the Court smoothly. She admit her mistake on her side due to the compelling circumstances. She assures that this will not happen again in near future. She look towards consideration and kindness to accept her apology."*

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 of Km. Shikha Pradhan, Additional District & Sessions Judge, Kasganj be laid before Hon'ble Mr. Justice Siddharth, Administrative Judge, Kasganj Judgeship for His Lordship's kind perusal and orders?
