

## **Registrar(J)(Budget)**

May kindly see the property statement received online from Smt. Poonam Rajput, Spl. Judge (U.P. Dacoity.A.A.), Mainpuri, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

**In the financial year 2018-2020 (2018-19 & 2019-20)**, the Gross income from salary is Rs.48,25,230/- and total deductions/ repayment/ savings/ investment against GIS, GPF, PPF, FDR, Personal Loans repayments and Income Tax are Rs.19,08,569/- and the balance of her savings bank account is also increased by Rs.1,37,601/- in this financial year from previous year's balance, total of which is Rs.20,46,170/-. Thus, a sum of Rs.27,79,060/- was therefore available with her to meet out the household expenditure of her family consisting three members of the financial year 2018-2020 (2018-19 & 2019-20).

In this connection, it is submitted that the officer has already submitted her movable and immovable property statements of the financial year 2016-2018 (2016-17 & 2017-18), online against Case Id : P00038152021 (Old Case Id : 5963) and the same has been processed before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Mainpuri for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 18.12.2021. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated that "*due to COVID 19 Pandemic situations and misplacement of documents i was not able to submit my statement on fixed time. It is prayed to condone the delay in filing the statement.*"

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Smt. Poonam Rajput, Spl. Judge (U.P. Dacoity.A.A.), Mainpuri, be laid before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Mainpuri Judgeship for His Lordship's kind perusal and orders?
