May kindly see the property statement submitted online by Sri Kamala Pati-II, Additional District & Sessions Judge, Muzaffarnagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.33,91,308/- and total deductions/savings/ investment against NPS, GIS, PPF, LICs SBI MFSL, Income Tax, Repayment of home loan & car loan is Rs. 16,24,986/-. Thus a sum of Rs.17,66,322/- was therefore available with him to meet out the household expenditure of him family consisting five members in both the financial years. The balance of Rs. 54,697/- has decreased from his saving bank A/c against the balance of the previous year.

In this connection, it is submitted that the Officer has already submitted his property statement of financial year 2017-18, which has been already seen by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Barabanki in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 11.12.2021. As such, there is delay in submitting the same. In this regard, officer has stated that due to mother sickness, brother's mouth cancer and unprecedented Covid-19 condition so that he could not submit in due time. He begged to say the Hon'ble Court please condone the delay.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Kamala Pati-II, Additional District & Sessions Judge, Muzaffarnagar be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffarnagar for His Lordship's kind perusal and orders?
