May kindly see the property statement submitted online received from Smt. Neetu Pathak, Additional District and Sessions Judge, Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2018-20 (2018-19 & 2019-20), her total income from salary and other sources is Rs.48.12.082/- and total deductions/savings/investments against CPF, GIS, Income Tax, Insurances, PPF and the balance of her savings bank account(s) is also enhanced for Rs.1,28,537/- this financial year from previous year's balance, total of which is Rs.17,43,245/- . Thus a sum of Rs.30,68,837/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that husband of the officer Sri Gaurav Sharma is ADJ whose annual income is 27 lacs and 18 lacs. respectively.

In this connection, it is submitted that the officer has already submitted her property statements online upto the financial year 2016-18 (2016-17 & 2017-18) which had already been seen offline by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Lucknow in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide her online application dated 11.12.2021. As such, there is delay in submitting the same from the part of the officer.

May therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Smt. Neetu Pathak, Additional District and Sessions Judge, Ghaziabad, be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Ghaziabad for His Lordship's kind perusal and orders?
