May kindly see the property statement submitted online received from Sri Arjun, Additional. Civil Judge (Sr.Div.)/ACJM, Agra, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2016-18 (2016-17 & 2017-18), his Total income from salary is Rs. 9,37,749/-and total deductions/repayment/investments against NPS, GIS, PPF, Income Tax, SIP and the balance of his savings bank of account(s) is enhanced for Rs.52,200/- this financial year from previous year's balance. Total of which is Rs.3,53,871/-. Thus a sum of Rs.5,83,878/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years 2016-17 & 2017-18.

It is pertinent to mention here that the wife of the officer earned Rs.10 lakh per annum from forensic science lab Delhi government (Designation- Senior scientific Assistant).

In this connection, it is submitted that the officer has already submitted his property statements offline upto the financial year 2015-16 which had already been seen by Hon'ble Mr. Justice Manoj Mishra, the then Administrative Judge, Meerut with the direction that the delay in submission of property statements at the time of joining of service has been explained by the officer by claiming that after joining service he started training at J.T.R.I., Lucknow and remained there till June, 2018 under the orders of Hon'ble High Court and due to this he could not timely submit property statements and the delay was not intentional. Further, vide letter dated 19th November, 2018, he has submitted statement of immovable property by reiterating the same explanation.

The report of the concerned Section Officer dated 21st December, 2018, which has been forwarded by the Registrar (J) (B) under his signature dated 2nd January, 2019, has been perused. From the report it does not appear that the property statements of the officer are disproportionate to his known source of income. Accordingly, let the statements submitted by the officer be kept on record. However, the officer should be cautioned to be careful in future and not to commit such mistake.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide his application dated 10.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that due to new in service and transfer from Meerut to sambhal in mid term he could not submit the statement on time he will not doing the same mistake in future.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Arjun, Additional Civil Judge (Sr.Div.)/ACJM, Agra, be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Agra, for His Lordship's kind perusal and orders?
