

## **Registrar(J)(Budget)**

May kindly see the property statement online received from Sri Rakesh Kumar-V, Additional District & Sessions Judge, Kaushambi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2005-07 (2005-06 & 2006-07) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2005-07 (2005-06 & 2006-07) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

**In the financial years 2005-07 (2005-06 & 2006-07)**, his gross income from salary is Rs.4,29,707/- and total deductions/Savings/investments against GPF, GIS, Income Tax, HRR and Insurances are Rs.1,10,373/-. Officer has not provided saving bank account details. In this regard, officer verbatim: "I have S.B. a/c in Bank Of Baroda, Bareilly and that was untouched till now. Recently, with my best efforts, an information has sought by me to the Branch Manager, B.O.B. for providing the balance in my saving bank account as on 31-03-2005. In context of that, Branch Manager has given an information on mail, dated 10-11-2022 that he is unable to fetch the details of my that saving bank account (Mail attached). Several efforts have been made by me to obtain the bank account detail of my Bank of Baroda saving bank account but unfortunately I couldn't receive any information about that till now." Thus a sum of Rs.3,19,334/- was therefore available with him to meet out the household expenditure of his family consisting two members in the financial years 2005-07 (2005-06 & 2006-07).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2003-05 (2003-04 & 2004-05) online against case id:P00038602021 (old case id-6008) and same has been processed before Hon'ble Mr. Justice Vikas Budhwar, Administrative Judge, Kaushambi Judgeship for His Lordship's kind perusal and orders

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2005-07 (2005-06 & 2006-07) in its next financial year i.e., 2007-08 upto March 2008. He has submitted movable and immovable property statements for the financial years 2005-07 (2005-06 & 2006-07) vide online dated 13.12.2021. As such, there is delay submitting the same. In this regard, officer verbatim: "..... I have been engaged in the treatment of my wife and son from the year 2009 to 2019 and from the year 2019 to 2021 respectively. During the treatment any how my wife's life was saved and son's leg was operated upon. The undersigned was mentally disturbed during the treatment. Due to above reasons, I was able to submit my property statement in the year 2021 after my wife and son became healthy. I apologize for the inconvenience caused to your goodself due to above reasons. The undersigned accepts his mistake and apologizes for not being able to submit the property statement in time. Inconvenience is highly regretted.

May, therefore, if approved, property statements for the financial years 2005-07 (2005-06 & 2006-07) of Sri Rakesh Kumar-V, Additional District & Sessions Judge, Kaushambi be laid before Hon'ble Mr. Justice Vikas Budhwar, Administrative Judge, Kaushambi Judgeship for His Lordship's kind perusal and orders?
