May kindly see the online property statement received from Sri Milind Kumar Singh, Civil Judge (Senior Division), Kannauj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below:-

In the financial years 2017-19 (2017-18 & 2018-19), his gross salary is Rs. 25,61,434/- total deductions/savings/investments against NPS, GIS, Income Tax, Insurance Policies, PPF, repayment of car loan and the balance of his S.B.A/c has enhanced for Rs.7,95,157/- this financial years against the balance of previous year's, total of which is Rs.18,16,430/-. Thus a balance of Rs. 7,45,004/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements of the financial years 2015-17, which has already been processed before Hon'ble Mr. Justice Ajai Kumar Srivastava-I, Administrative Judge, Kannauj Judgship on old case Id no-6111.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e.,2019-20 upto 31st March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide his application dated 15.12 2021. As such, there is delay in submitting the same from the part of the officer. In this regard, officer has stated that he could not submit the abovementioned statements within time due to the heavy work load of Courts and non availability of relevant documents. The officer tenders unconditional apology for this delay, he will follow the mandate of the Hon'ble High Court in future and will furnish the statements well in time.
