May kindly see the property statement online received from Sri Abhinitam Upadhyay, Additional District & Sessions Judge, Balrampur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total Gross income (including arrears for LLM increments) is Rs.51,01,237/- and total deductions/ repayment/ savings/ investment (for both the financial years) against PRAN, GIS, Income Tax, PPF, PLI, Insurance policies and loans are Rs.22,30,903/-. Thus, a sum of Rs.28,70,334/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.91,733/- this financial year from previous year's balance.

It is pertinent to mention here that his wife earns annual income of Rs.3,57,374/- and Rs.4,65,715/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18, which had already been seen by Hon'ble Mr. Justice Rajesh Dayal Khare, the then Administrative Judge, Aligarh in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 24.11.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial year 2018-19 & 2019-20 of Sri Abhinitam Upadhyay, Additional District & Sessions Judge, Balrampur be laid before Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Balrampur for His Lordship's kind perusal and orders?
